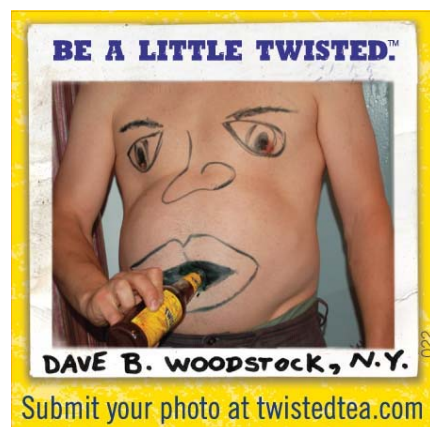
Image Type: Neck
